1. The appointment for the post of Senior Resident (Gastroenterology) on regular basis for a period of three years in the pay scale of Rs.15,600/- + GP Rs.6600/- plus other allowances, for the post of Senior Resident (Cardiology) against leave vacancy on adhoc basis for a period of 89 days in the pay scale of Rs.15,600/- + GP Rs.6600/- plus other allowances and Junior Resident on regular basis for a period of one year in the pay scale of Rs.15,600/- + GP Rs.5400/- plus Other Allowances as applicable.
2. The above vacancies are subject to change and the institute reserves the right whether or not to fill up any post. No appeal in this regard will be entertained at any time. Before applying, the candidate must satisfy himself of the eligibility conditions as per the Eligibility Criteria.
3. Upper age limit is relaxable by 5 years for SC/ST candidates and by 3 years for OBC candidates. For the post reserved for OBC category, the application of those candidates will be considered who have OBC certificate issued by Government of National Capital Territory of Delhi. In respect of persons with disabilities, upper age limit is relaxable by 5 years (10 years for SC/ST and 8 years for OBC) subject to the condition that no age relaxation can be allowed beyond the age of 60 years under normal circumstances except for faculty positions.
4. The candidates with the disabilities can apply for the post as per the definition given in the Persons with Disabilities (equal opportunities, protection of rights and full participation) Act, 1995.
