The selected Candidates for the post of Senior Residents shall be appointed initially for a period of one year further extendable upto a maximum of three years on the basis of satisfactory performance appraisal report with inter-alia a notice period of one month from either side for severance of contract.
- 5. The selected Candidates for the post of Junior Residents shall be appointed for a period of one year with inter-alia a notice period of one month from either side for severance of contract.
- 6. The period of service rendered by a candidate as Senior Resident and Junior Resident in Govt. Hospitals/Autonomous Bodies funded by the Govt./Private Nursing Homes prior to this appointment, if any, will count while reckoning the tenure as Senior Resident and Junior Resident.
